- Apprenticeship in a relevant trade
- HNC or relevant experience
- Have experience in a Electrical role in a regulated industry
- Able to obtain security access to nuclear installations. (BPSS – P4/SC Clearance)
- Able to supply a current DBS criminal records check.
- Willing to travel / overnight when required
- Able and willing to work in nuclear facilities, including situations requiring use of specialist PPE e.g. PVC and respirators. (This includes attending all mandatory Sellafield training courses and medicals)
